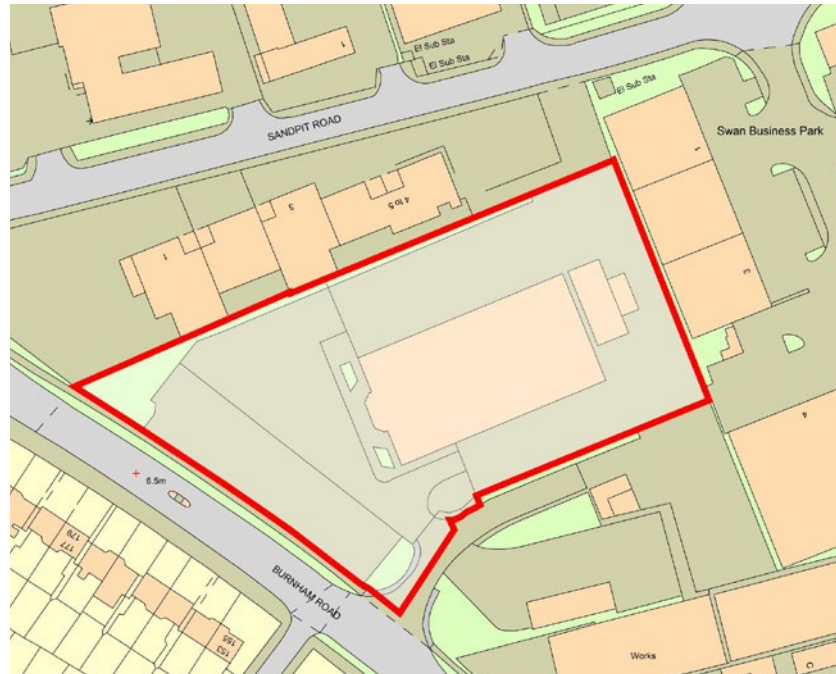
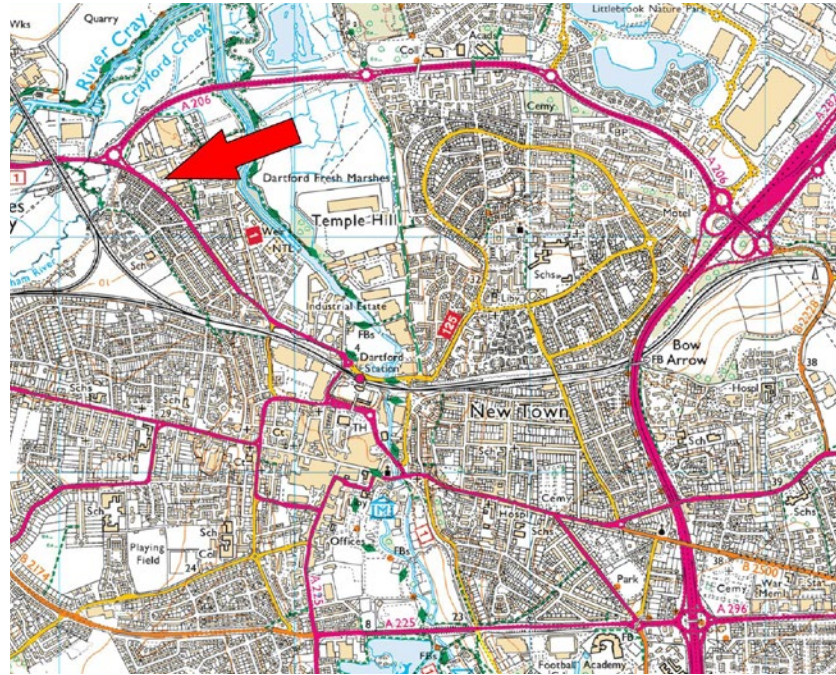

LOCATION

Located 1 mile north of Dartford town centre and main line railway station and within 2 miles of Junction 1A of the M25 motorway and the Dartford River Crossing. The site is highly accessible and is situated next to ASDA Dartford Click and Collect Centre.

DESCRIPTION

Prestige car showroom and workshop owned and operated by Mercedes-Benz.

The property comprises a spacious 9 car showroom, with a 12 bay workshop (including MOT), parts storage, SMART repair unit, offices and ancillary accommodation.

Externally, landscaped parking areas comprise 85 display and customer spaces at the front and 110 parking spaces to the sides and rear.

PLANNING

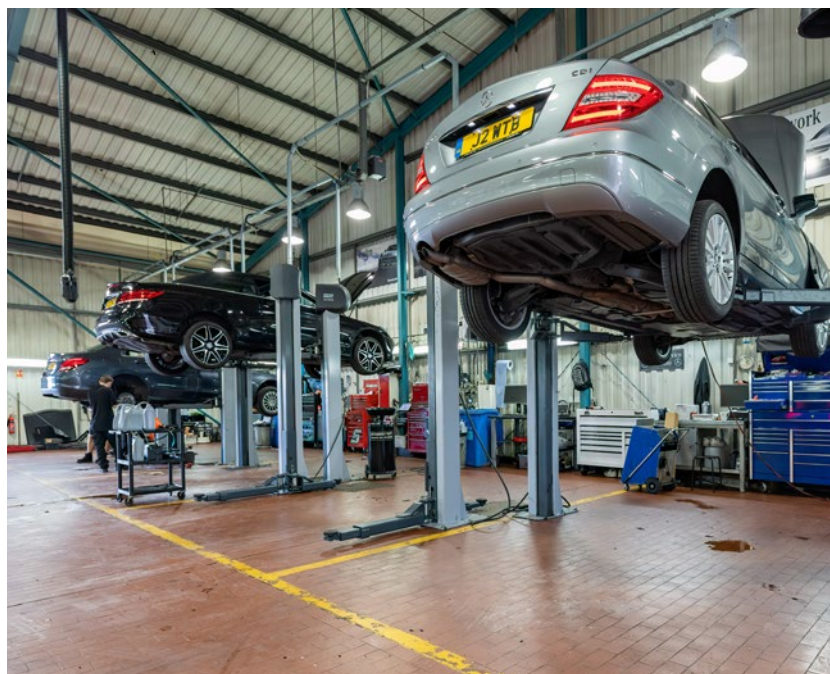
The property has planning permission for its existing use but also has potential for alternative uses subject to obtaining the appropriate planning consents. Dartford Borough Council is the local planning authority.
